Purpose of Survey: Retrace original survey of outside boundaries of Tract and survey and describe two parcels of that portion lying West of a County Road.

Detail of proceedure: Began at the SE corner of Section 17, T.37 S. R.2 W. W.M., Oregon, the corner being a granite stone with an X chiseled on top; thence chained North on the East line of said Section a distance of 2568.80 feet to the East # corner of said Section which is marked with a granite Stone with an X on top; thence ran West following the original survey a distance of 1331.0 feet to a point on the West side of a county road said point being marked with a $3^{tt}x$ $6^{tt}x$? sandstone Mon. scribed $\frac{1}{44}$ as the beginning point as described in the notes of the original survey.
