

Purpose of survey: To establish the outside boundaries of the said Lots 1 to 6 inclusive and set corners of same and stake and described tracts in portion of lots 4 and 5 as shown on the accompanying plat and shown by the following descriptions.

Detail of proceedure:

Began at a 2" galvanized iron pipe set on the north line of Donation Land Claim # 48, T.38 S. R.1 E. W.M., Oregon, which pipe is located N.89°30'E. 60.0 feet from the southeast corner of Block "F" of the Rogue River Valley: Orchard Company's Tracts; thence following the north line of said Claim S.89°30'W. 60.0 feet I chiseled an X in concrete slab at the southeast corner of said Block; thence continueing along said claimline from said X S.89030 W. at a distance of 1461.20 feet came to the reestablished corner of Claim # 48, (northwest corner) and continued on same course 2127.6 feet, the distance set forth in the recorded plat as the distance to the southwest corner of Lot 6. There was no evidence of the original monument at this point so I set a 3/4 inch pipe at this point; thence ran N.0000'19" W. (the calculated bearing of this course from a calculated closure of this area using the bearings and distances set forth in the original plat) a 🔞 distance of 771.4 feet, intersecting an east-west fence line. At this point I set an3/4 " pipe for corner; thence from this point I ran S.89°59'11" E. 1855.80 feet to the northeast corner of said Block "F" said corner being N.19052'W. 800.0 feet from the southwest corner of said Block, this point falling in the center of a large corner fence post. I than surveyed the boundaries and set pipes at the corners of the 5 tracts constituting that portion of Lots 4 and 5 according to that appearing on the accompanying map and as
