**DESCRIPTION**

Commencing at a point on the north line of Section 27, T.39 S. R.1 E., W.M., Oregon, which point is N.39°53' E. 1322.2 feet from the northwest corner of said Section; thence due South 799.7 feet to the northwest corner of the Mt. Pitt View Mining Claim, the true point of beginning; thence South 200 feet to a post which bears due West 150 feet from the point of discovery; thence South 400.0 feet to the southwest corner of said Claim; thence East 1500 feet to the southeast corner thereof; thence North 400 feet to a post which bears 1350 feet East of the point of discovery; thence North 200 feet to the northeast corner thereof; thence West 1500 feet to the true point of beginning.

**Corners & References.**

N.W. Corner: A 3" x 3" x 4' Post scribed 0-6 from which an 18" Red Fir, scribed L.S. 0-6 BT bears S.65°W. 19 feet and a 16" Red Fir scribed LS 0-6 BT bears N.40°W. 9.8 feet. Point on West line: A 4" x 4" x 4' Post scribed 1 from which a 16" Red Fir bears S.56°45'E. 11.5 feet and an 18" Red Fir bears N.30°E. 10.6 feet. S.E. Corner: A 3" x 3" x 4' Post scribed 2 from which a 10" Red Fir bears N.71°30'W. 13.8 feet and a 14" Red Fir bears N.53°E. 10.5 feet.

S.E. Corner: A 3½" x 3½" x 4' post scribed 3 from which an 8" Red Fir bears S.57°45'W. 14.0 feet and an 8" Red Fir bears S.23°E. 10.7 feet.

Point on East line: A 3½" x 3½" x 4' Post scribed 4 from which a 10" Red Fir bears N.55°W. 10.0 feet and a 12" Red fir bears N.33°30'E. 9.9 feet.

N.E. Corner: A 3½" x 3½" x 4' Post scribed 5 from which a 12" Red Fir bears S.39°E. 11.3 feet and a 10" Red Fir bears S.55°W. 12.9 feet.



