Dear Mr. Rynning:

Referring to yours of July 29th I went to Tubb Springs on August 2nd and checked on the  $W^1_{\overline{u}}$  corner, Section 2, Township 40 South, Range 3 East, W.M. and could not find any evidence that the corner had been found. No one had chopped deeper into the tree, there were no scribe marks and no other trees in the vicinity had been blazed or chopped into.

Talked to Mr. L. E. Ager, Ashland, on the phone later in the evening. He told me that he had run to that location and noted that the tree had been marked B.T. in aluminum and the blazes had been chopped out and assumed that it was the original B.T.. He did not examine it closely, as it was late, to see if it was scribed and said he saw none.

Therefore assumed our data was correct and made no changes on the West Section line. Did change the NE & SE corners of State Parks property. This was done refiguring the location of the centere quarter corner. For the north and south center section line I used the  $N_{14}^{1}$  and  $S_{14}^{1}$  corners as found and for the east and west center section line I use figured locations for the  $W_{14}^{1}$  and  $E_{14}^{1}$  corners.

A print of revised map showing bearings and distances is attached.
