
Map of Survey for, Johnston & Plumley Inc. Medford, Oregon.

Survey narrative to comply with Section 87 - 330 Oregon State Law of 1947.

For: Johnston & Plumley Inc., Medford, Oregon.

Purpose: To establish the boundaries of the south  $\frac{1}{2}$  of Section 8, T. 1 S., R.3 W., W.M., Jackson County, Oregon.

Proceedure:

Began at a stone scribed \( \frac{1}{4} \) at the east \( \frac{1}{2} \) corner of the Section, found a yellow pine, green standing, in Section 9, (scribed B.T.), the pine B.T. in Section 8 was dead down having been burned off at the stump both trees checked by bearing and distance from the stone according to the original field notes. From this corner I retraced the section line on a compass variation of 1803014. of magnetic north along a blazed line (old and new blazes) South to the southeast corner of the section which was marked with a 2" iron pipe with brass cap and B.Ts. From this corner I compassed west (Var. 170) along a plainly marked line which was marked at the time of the resurvey of the south line of the section. This line led direct to the south \( \frac{1}{4} \) corner which was marked with a 3/4" iron pipe with brass cap and 2 pine B.Ts. Thence I continued west along same blazed line to the southwest corner of the Section to a 2" iron pipe set in mound of stone with B.Ts. in evidence. Having made a search for the west a corner which was supposed to be on the Squaw Cr. side of the mountain according to the original field notes and not finding same I chained north (Var. 180301) from the southwest corner, ( there being no timber near this west line) and this being a cutting line for logging only, I considered a compass line sufficient, to the top of the mountain a distance of 1960 feet which indicated an error in the orig. field notes as to location of the  $W.\frac{1}{4}$  corner. I continued north a distance of 2640 feet from the S.W. cor. and made a search for this 4 corner, only one small madrone was shown for a B.T. and a scribed stone. This area was devoid of rock and there were several clumps of Madrone trees, ( small) in this area. I continued North and on entering larger timber I found a line of blazes along my compass line which led to the northwest corner of the Section a distance of 5296 feet from the southwest corner. Returned to make a furthur search for the W. 1/4 corner. after searching this area I found the scribed \( \frac{1}{4} \) corner stone under debris which was smaller than the field notes indicated, this being set in a circle of smaller stones, from this a clump of madrone checked according to bearing and distance for the location of the B.T., only a rotted stump of the B.T. remaining. This stone falling on a projection of the blazed line from the N.W. corner and being 2634 feet from the N.W. Cor. & 2662 feet from the S.W. cor. From this W. cor. I swamped a line to the trail on top of ridge and ran a traverse from this  $\frac{1}{4}$  cor. to the east  $\frac{1}{4}$  corner the computed bearing between these points to be S.87°18'E., than blazed and painted the true line between these points.
