

## SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 OREGON REVISED STATUTES

LOCATION:

The Southeast quarter of Section 1, Township 37 South, Range 2 West of the Willametre Meridian, Jackson County,

Oregon.

BASIS OF BEARING: Jackson County previous adjusted traverse: East line of

the Southeast quarter - N0°00'27"E 2662.11.

PURPOSE OF SURVEY:

To determine the boundary line between the Airport property and the Fruit Growers League ownership, also to verify the encroachment of a trailer. The determination factor being deed records Volume 422, Page 108 which is a tract conveyed to the Fruit Growers League which calls for monuments as shown on Survey No. 788. This would require a retracement of said survey replacing lost or damage monuments along the common boundary.

The remeasurement of this boundary between owners, concurs close to that of record and Survey No. 788.

## MONUMENTS:

(1) Found 1" pipe, 2" high (see Survey No. 788).

(2) Set 5/8 x 24 ins. iron pin flush with plastic cap mkd. Jackson Co.

(3) Set 5/8 x 24 ins. iron pin set 5 ins. deep with plastic cap mkd. Jackson Co.

(4) Found ½ ins. pipe 7 ins. deep and 0.03 ft. northerly of center line of Pech Road.

(5) RP. mkd X on concrete apron.

(6) Found 1½ ins. pipe in center of access road, 8 ins. deep.

(7) Set 5/8 x 24 ins. iron pin flush with plastic cap mkd. Jackson Co.

(8) Found 5/8 ins. iron pin bent northerly, approx. 0.22 ft. (see survey No. 788).

(9) Found brass cap 2½ ins. diam. in concrete mon., 14 ins. deep.

(10) Found brass cap mkd. k S 1/6 18 ins. deep.

11) Found 1 ins. iron pin, 6 ins. deep, shown on Survey No. 788.

(12) Found concrete mon. and brass disc in mon case (Table Rock Road).

(13) Found 1½ ins. square bolt, 3 ins. deep and 3 ft. South of E-W fence.

(14) Found 1 ins. pipe flush, 3 ft. East of fence.
