

North Quarter Corner, Cor. Secs. 34&3 found Co. Surveyor brass cap in 1" G.I. Pipe, and B.T.'s: 32" D. Fir S 5°E 17.2', O.B.T. down & dead, rec. S 15°E, scribe vis. 30" I. Cedar N 5°W 5.9', O.B.T., open, rotted face, w/cruiser marks. 12" S. Pine N 39½°E 43.4', healed 11" P. Pine S 19°W 21.2', healed Cor. is 30' N'ly of ridge top, W'ly.

½ Corner Sections 4&3, found Co. Surveyor brass cap in 1" G.I. Pipe, and B.T.'s: 28" P.Pine N 45°E 8.5', 0.B.T., open, scribe vis. 16" I. Cedar S 45°E 29.7' to face, C.S., 1933, "BT" scribe vis. Cor. is 60'± W. of Creek, SW'ly, on small bench.

Narrative Description to comply with Par. 209-250 (Note 1 map sheet accompanies this narrative)

Purpose: As stated above

Procedure: Copies of all pertinent available information, ie. U.S. General Land Office (G.L.O.) original field notes, Bureau of Land Management (B.L.M.) and Jackson County corner re-establishments, and Survey No. 4734, were obtained from the Jackson County Surveyor. The original G.L.O. Survey had been performed by David P. Thompson in 1857. In 1971 Survey No. 4734 had set the Southeast corner of Section 3 by double proportionate measurement. My Survey No. 10029 had checked Survey No. 4734's work on 2 of the 4 lines surveyed in setting said corner, and found it quite satisfactory.

All of the corners of unknown position that were needed for subdividing Section 3, were tied in by my E.D.M. control survey, using Kern 20-Second Theodolite and K&E Autoranger II equipment, supplemented by steel tape. After office computations and preliminary mapping, the required new corners were set and the specified boundaries were surveyed and marked, as shown on my map. Said boundaries were marked with red-painted blazes, red flagging, and aluminum "P/L BCC" tags. Monuments set were 5/8"X 30" Iron Rods with yellow plastic cap marked "Thompson PLS 1358". Corners found or set are as follows:

Original G.L.O. bearing trees (O.B.T.'s) and Survey No. 4734 B.T.'s were measured to the "face" position; other bearing trees were measured to the centers, unless stated otherwise.

Corner Sections 2,3,10,11 found Survey No. 4734 1" G.I. Pipe w/reducer, and B.T.'s, all w/healed faces: 24" D. Fir N 32½°E 19.9' (rec. 19.3' to face) 10" D. Fir S 9°E 40.4" 12" D. Fir S 74°W 37.7' (rec. 37.5' to face)
12" P. Pine S 67°W 51.3' (rec. 51.0' to face)

South 1/16 Corner Secs. 3&2 found Survey No. 4734 1" G.I. Pipe w/reducer, and B.T.'s w/healed faces: 12" D. Fir N 43°E 6.6'
11" D. Fir N 77°W 12.7'

½ Corner Secs. 3&2 found Survey No. 4734 1" G.I. Pipe w/reducer, and B.T.'s w/healed faces: 13" D. Fir S 71½°W 6.3' 16" D. Fir S 34°E 11.1' Corner adjoins E'ly side of logg. rd., N'ly & SE'ly.

North 1/16 Corner Secs. 3&2 found Survey No. 4734 1# G.I. Pipe w/reducer, and B.T.'s w/healed faces: 16" D. Fir N 61°W 53.0' 17" D. Fir S 40°E 33.7' Corner adjoins E'ly side of logg. rd., N'ly & SE'ly.

Corner Sections 2,3,34&35 found B.L.M. 1965 brass cap in 2" G.I. Pipe, and B.T.'s:

21" Madrone N 77°E 27.7' O.B.T., open, no scribe visible 22" B. Oak S 80°W 44.9', O.B.T., broken 12' stub, healed face 25" Madrone N 65°W 43.6', O.B.T., open, scribe vis. 6" P;Pine N 47°E 47.5', healed 12" D. Fir S 1°E 45.5', healed 9" D. Fir S 83°W 40.0', healed 10" D. Fir N 41°W 39.6', healed

Corner adjoins W'ly side of logg. rd., N'ly & SE'ly.
