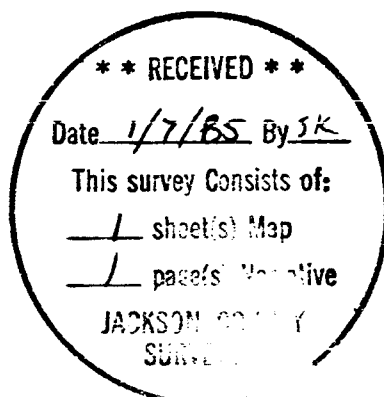
Purpose : Jackson County Minor Partition No. 84-49-MP
