

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250

LOCATION:

Northeast quarter of Section 32, Township 34 South, Range 1 West of the Willamette Meridian, in Jackson

County, Oregon.

BASIS OF BEARING: County Road S0°37'E.

PRECEDENCE OF SURVEY: This survey was made in conjunction with a survey to follow: The original monument set by Boyden for the East one sixteenth corner between Sections 29 and 32 was destroyed by flood or other unknown factors. The North line was traversed and an iron pipe 1 ins. in diam., 36 ins. long with plastic cap marked Jackson C.S. was set flush being on the section line at a proportional distance from which:

An original bearing tree, the Easterly fork of a Black Oak, 50 ins. diam. brs. S15 3/4°W, 423.5 ft. (See 1944 re-estab. by C.Z. Boyden).

An iron pin 5/8 ins., exposed 1 in., at the Southeast of fence corners, brs. N20°26'12"W, 3.49 ft. (apparently monument shown on survey no. 6205).

An iron pin 5/8 ins. diam, 24 ins. long, with plastic cap mkd. Jackson C.S., set 12 ins. deep, brs. N89°59'59"W, 123.38 ft.

The monuments found along the easterly line of the County Road and the P.I.'s, were set by the County Road Dept. in 1976-1978. Apparently the original P.I.'s were all recovered, however, according to remeasurement a small descrepancy was computed as to the monumented location of the easterly line. Pt 6 location was determined by holding record tangent distance on centerline and remeasured the delta angle at P.I. changing radius to fit. This would maintain the approximate record length of curves.

- (3) Previously described East sixteenth corner between Sections 29 and 32, 22,111.352 6414.908

- (4) Found 5/8 ins. iron pin previously described. 22,114.618 6413.691
- (5) Set an iron pin 5/8 ins. diam., 24 ins. long, 12 ins. deep as previously described. 22,111.353 6291.529
- (6) Set an iron pin 5/8 ins. diam., 24 ins. long, flush with plastic cap mkd CS Jackson County. 22,111.349 6097.825
- (7) Fd. 5/8 ins. pin, (Survey No. 6242). 22,111.518 6037.343 .
- (8) Fd. 5/8 ins. pin, 4 ins. deep, county road P.I. 22,072.890 6083.75 /
- (9) Fd. 5/8 ins. pin exposed 2 ins., county road P.I. 23,125.847 5841.521
- (10) Fd. 5/8 ins. pin exposed 2 ins., county road P.I. 20,949.055 6095.846.
- (11) Fd. 5/8 ins. pin approx. flush by the County Road Dept. set for beginning or end of curve.
- (12) Same as (11) except 3 ins. deep.
- (13) Fd. "X" on rock county road P.I. by County Road Dept. 20,093.303 6698.582 '
- (14) Fd. 5/8 i. pin approx. flush, shown on survey no. 6242. 20,791.648 6172.296
