PRECEDENCE OF SURVEY: Prior to the initial field survey and the basic search of public records, it appeared that it would be necessary to subdivide Section 32 to determine the title lines, "which would not agree with lines of possession or with boundary lines which were intended in deed records". It was first proposed that certain lines would be established on the ground at or nearest to the possible intent of deed or along the line of occupation which was agreeable with the adjoiners.

After making the preliminary survey and tying to existing monuments, some of which were attested to by older residence of many years, "that Clabby has surveyed a larger tract setting 3/4 ins. iron pipes in 1946". In searching Clabby's private records (file No. 6-46) and this was verified, that he did not subdivide Section 32 or locate the true Northwest corner of Government Lot No. 2. He also prepared a legal description, using the North quarter corner, to determine the approximate Northwest corner to Government Lot No. 2, which is called for on tracts shown on this survey. From the original tract description and survey by Clabby, subsequent owners subdivided tracts without the benefit of a survey.

The boundary line between the Hickes and the Thomases, calls for a straight line, however, it was agreed by parties that this boundary be located to agree with the boundary marked by iron bolts found and along an existing fence as shown.

The boundary line between Jackson County and the Hicks was located according to the best evidence as to the intent of the original conveyence, however, according to Mrs. Hicks, this is not the same line which was identified to them by previous owners as their north boundary and at the completion of this survey, this was not resolved. Note that other monuments set by previous owners were not surveyed or shown on this survey.
