PURPOSE:

To survey and monument South Half of Lot 22, RIVERVIEW ESTATES SUBDIVISION in the City of Shady Cove, Oregon.

PROCEDURE:

Recovered various original lot corner monuments along Rene
Drive, some of which are bent or otherwise disturbed, making
it difficult to determine the true original alignment of the
street. A traverse was conducted between these monuments,
to the original Witness Corner on the north line of Lot 22.
The location for the original Witness Corner on the south
line of Lot 22 now falls in the river.

An examination of the subdivision discloses that the lot lines on either side of Rene Drive were laid out to be contiguous.

Therefore, the north line of Lot 22 was established from the monument at the Northeast corner of Lot 7 and the aforementioned recovered Witness Corner

The south line of Lot 22 was established at record angle from Rene Drive, as no original Witness Corners could be found south of Lot 22. The river has apparently destroyed the Witness Corners for some distance south of Lot 22.
