

History of original corner establishment:
The center-west one-sixteenth corner for Section 30, Township 32 South, Range 4 East, Willamette Meridian, Jackson County, Oregon, was established by Donald L. Branch (P.L.S. #1137) during Record Survey No. 8596 dated 21 October, 1980.



Description of corner evidence found:

Found a $2\frac{1}{2}$ -inch diameter brass cap monument marked as shown in diagram, and the following accessories:

A 22-inch diameter fir bears N.78°15' E., 37.5 feet distance, with scribing visible on a partly healed blaze. (Note: This accessory was used as basis of bearing...var. 19°30'E.)

A 15-inch diameter hemlock bears $5.21^{\circ}00'W.$, 5.3 feet distance, with CW 1/16 S30 BT visible. This tree now dead.

Description of monument and accessories l'established to perpetuate the original location of this corner: I mark a new accessory as follows:

A 31-inch diameter fir bears N.57°30'W., 63.9 feet distance, scribed CW 1/16 S30 LS1071 BT.

Trees are marked with a 6-inch wide band of red paint and Forest Service signs are attached.
