

Bath, a duly Registered Surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

Commencing at a brass disc monumenting the North one-quarter (1/4) corner of Section 25, Township 37 South, Range 1 West, of the Willamette Meridian, Jackson County, Oregon; thence South 89° 45' 12" East (d.r. 
PURPOSE:

Subdivision development: SUN RIDGE ESTATES, PHASE I. to comply with specifications set forth

in Jackson County File No. 80-38-SP

procedure: The mathematical boundary of the Northeast quarter of Section 25 was determined by subdividing Section 25 as shown. The client's deed determined the Northerly, Westerly and Southerly boundaries of Phase I. Also, a portion of the Westerly boundary was determined by the 1936 relocation of Hillcrest Road where original evidence for Stations PT 266+11.4, PI 281+32.4, PI 283+35.5, and PI 314+82.7 was found and information from Map M-5-1 and Volume 3, page 264 of the Road Records was also used in establishing the monumented location of said Hillcrest Road.

The Easterly boundary of Phase I and interior lot lines were established per client's request and per specifications set forth in County File No. 80-38-MP.
