SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250.

Location: Located in Block 67 of Pool & Klippel's Addition to the City of Jacksonville, in Section 32, Township 37 South, Range 2 West of the Willamette Meridian, Jackson County, Oregon.

Purpose: To monument that tract of land identified as Parcel "A" on the accompanying map and the adjoining "parent tract" to the westerly.

Procedure: The recovered centerline monuments shown on the accompanying map were used to control the Block boundaries. The southerly line of the surveyed tracts is controlled by the following call: "thence southeasterly of a point 120 feet North of a point on the northerly line of "D" Street where the Southerly line of said Block 67, as extended, intersects a line 12.80 chains west and parallel to the east line of Donation Land Claim No. 37 ..." The Southeast corner of D.L.C. No. 37 was tied on this survey, and the record N0°06'30"E bearing was held for the east line. The point as shown on the accompanying map represents the above deed call.

The deed for the subject Parcel "A" (86-09132) and the deed for the adjoiner to the south (81-23458) are in agreement.

The center line of 6th Street as recovered was utilized as the basis of bearing.
