

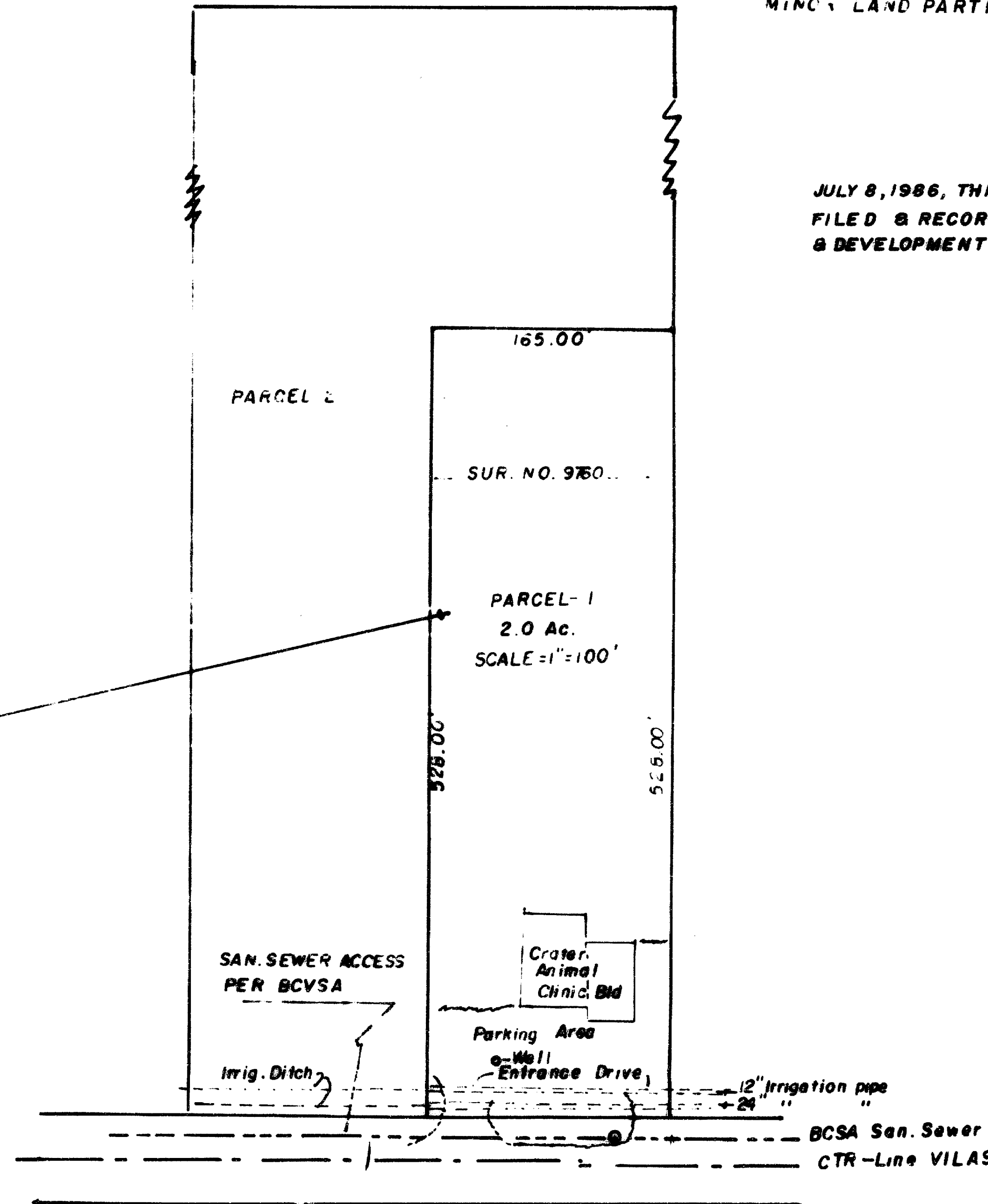
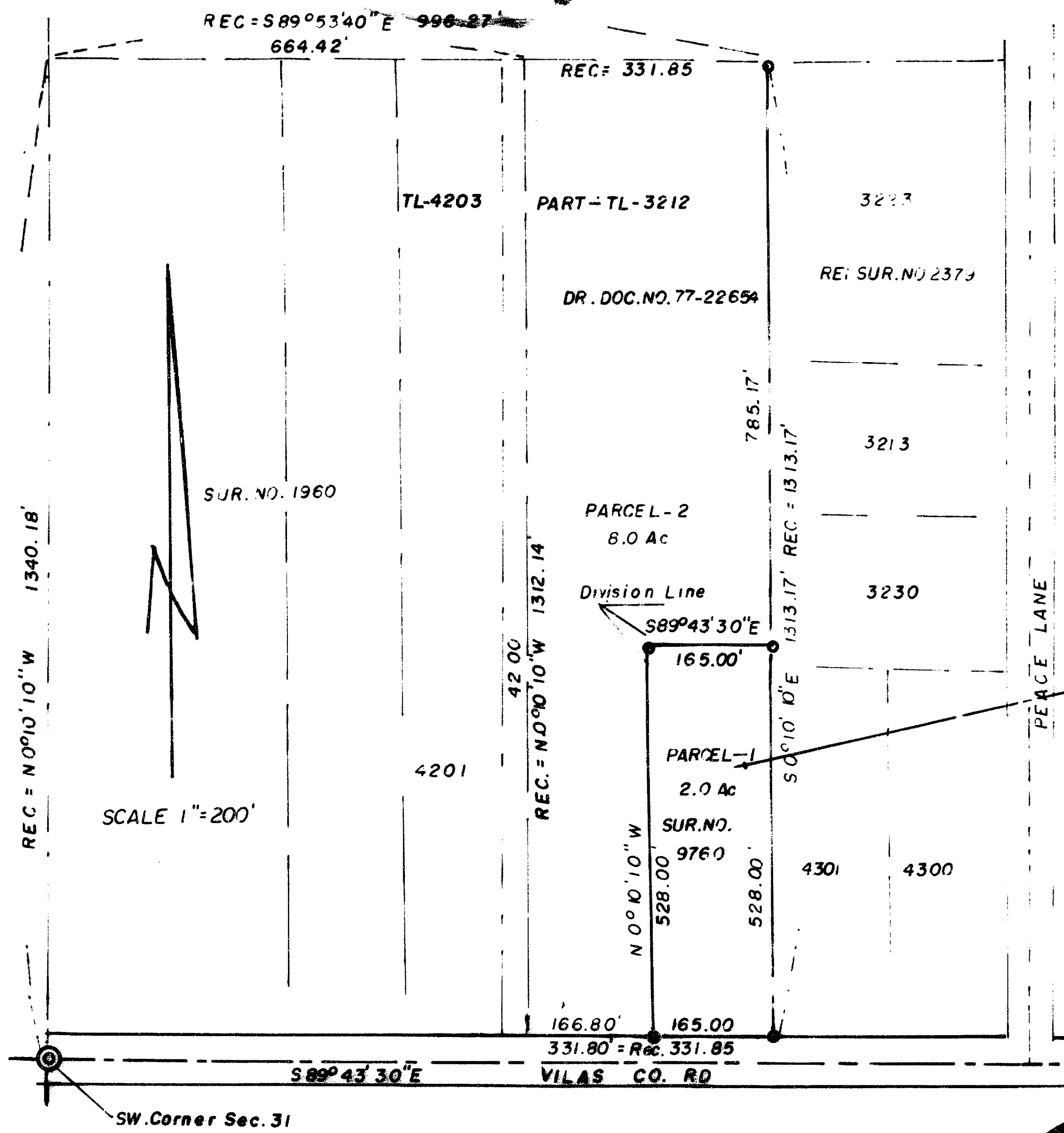

- (2) NO DEVELOPMENT MAY OCCUR WITHIN 60 FEET OF THE WESTERLY PROPERTY LINE (ON PARCEL 2). THIS RESTRICTION IS SET FORTH IN ORDER TO ACCOMMODATE POTENTIAL FUTURE PUBLIC STREET DEVELOPMENT.
