


Location:

Northeast 1/4, Section 5, Township 36 South, Range 2 West, Willamette Meridian, Jackson County, Oregon.

Purpose:

To survey and monument corners of parcel shown on annexed plat.

Procedure:

Made control survey ties to the existing corners of Section 5, determined that the South 1/4 corner and the West 1/4 corner of the Section were lost and a proportinate position was calculated for them.

From the measurements returned the fractional lines of the section were calculated and the corners of the subject parcel were monumented as shown on the annexed map.

The following described corners were used for control.

- 1. N.E. corner Section 5, found County Surveyor's brass cap in monument case.
- 2. North 1/16 corner Section 4 and 5, found 1" iron pipe with 2 1/2" brass cap marked RLS 803.
- 3. East 1/4 corner Section 5, found 1" conduit pipe in rock mound with BTs per Survey No. 7534. (No evidence of 1" brass capped pipe) set PLS 961 cap in conduit pipe.
- 4. S.E. corner of Section 5, found B.L.M. brass capped pipe set in 1957.
- 5. S.W. corner Section 5, found County Surveyor's brass capped pipe set in 1976 per re-established notes.
- 6. N.W. corner Section 5, found 5/8 inch iron pin established by Survey No. 3955 which reported the corner re set from 0.S.H.D. references to a corner established in 1914.

7. North 1/4 corner Section 5, found County Surveyor's brass cap in monument case.
