



LOCATION:

Situated in Government Lot 4. Section 5. Township 39 South, Range 1 East. Williamette Meridian, Jackson County, Oregon.

PURPOSE:

To survey and monument a partition as approved by the Ashland Planning Commission.

PROCEDURE:

Utilizing monuments set on Recorded Surveys No 6195, 4147, and 10103 proceeded to evaluate the boundaries of the subject tract to be partitioned. Commenced this survey at the accepted Southwest corner of Government Lot 4, Section 5, Township 39 South, Range 1 East, Willamette Meridian, said point monumented by a 2" iron pipe per R.S. No. 6195, traversed to the accepted northwest corner of Government Lot 4. Section 5, Township 39 South, Range 1 East, Willamette Meridian, said point monumented by a bronze cap in a monument case located at the intersection of Scenic Drive and Wimer Street. Bearing and distance between the monuments established accepted centerline right of way of Scenic Drive and the west boundary of the subject property. Continued traverse along south right of way of Wimer Street, establishing the north boundary of the subject property, locating iron pins set during Record of Surveys 4147 and 10153. Also located during this survey, a 1" square iron bar set by McCall (approximately 1888) monumenting the centerline of Susan Lane and the West line of Donation Land Claim No. 40. Traversing west from said monument, iron pins monumenting the cul-de-sac at the west end of Susan Lane and the north right of way of Susan Lane were located and compared to deed record for position; respective locations of found monuments are noted on accompanying plat. Parcels 1, 2, and 3 were partitioned according to client instructions. Ideally Parcels 2 and 3 were to be equal in area with identical frontage abutting the cul-de-sac on the west end of Susan Lane. The Witness Corner was necessary because true position fell upon a concrete footing for an existing fence corner.
