

Basis of Bearing:

Solar Observation

Purpose:

To monument the corner points described within deed documents Nos. 86-14421 and 86-22477 and the adjusted boundary line between said parcels.

Procedure:

Utilizing previously established control points established by me, I performed a series of closed traverses around the perimeter of each parcel. From this data I computed and established the corner points as shown on the attached map of survey. The West boundary of the tract described within deed No. 86-14421 was controlled by a call within deed No. Vol. 93, page 266. Establishment of this line differed considerably from the use line. This line was adjusted to the West as directed by attorneys representing each landowner.
