McMahan, a duly Registered Surveyor of the State of Oregon, being first duly sworn, do hereby certify that I have correctly surveyed and marked with the property monuments as provided by law the tract of land hereon shown and the said plat is a correct representation of the same, and the following is an accurate description of the boundary lines.

Commencing at a point in the center of East McAndrews Road on the West boundary of Donation Land Claim (D.L.C.) No. 63 in Township 37 South, Range 1 West of the Willamette Meridian in Jackson County, Oregon, which bears South 00° 18' 30" West 1330.70 feet from the re-established Northwest corner of said D.L.C.; thence North 89° 53' 30" West, along the centerline of said road, 693.75 feet (Record 693.55 feet) to the East line of that tract as described in Volume 253, page 600 of the Official Deed Records of said Jackson County; thence, along said East line, South 00° 00' 56" East 170.85 feet to a brass disc in concrete for the INITIAL POINT OF BEGINNING; thence continue South 00° 00' 56" East 215.55 feet to a 5/8 inch iron pin; thence South 21° 25' 05" East 2.77 feet to a 5/8 inch iron pin; thence South 00° 12' 43" East 273.67 feet to a 5/8 inch iron pin; thence West 1.95 feet to a 5/8 inch iron pin; thence South 00° 00' 56" East 21.77 feet to the South line of that tract as described in Volume 477, page 94 of said Official Deed Records; thence, along said South line, South 89° 53' 30" East 356.41 feet to the point of terminus of a certain boundary line agreement recorded in Jackson County Instrument No. 88-10221; thence North 00° 57' 52" East (Record North 00° 57' 20" East), along said agreement line 325.02 feet to the South terminus of a certain boundary line agreement recorded in Jackson County Instrument No. 72-04639; thence North 00° 57' 52" East (Record North 00° 57' 20" East), along said agreement line, 224.47 feet to a point that is South 00° 57' 52" West 110.00 feet from the South right-of-way line of East McAndrews Road; thence North 89° 53 30" West, parallel with said South right-of-way line, 143.20 feet to a point that is 50.00 feet Easterly of, when measured at right angles to, the line described as a certain boundary line agreement recorded in Jackson County Instrument No. 78-27174; thence North 01° 01' 40" East, parallel with said agreement line, 90.32 feet; thence along the arc of a 20.00 foot radius curve to the right (the long chord to which bears North 45° 34' 05" East 28.06 feet) an arc distance of 31.10 feet to a point on the South right-of-way line of East McAndrews Road; thence, along said South right-of-way line, North 89° 53' 30" West 69.69 feet to the point of beginning of the aforementioned Boundary Line Agreement recorded as Instrument No. 78-27174; thence along said boundary line agreement line, South 01° 01' 40" West 145.50 feet (Record South 01° 30' 00" West 145.54 feet) to the point of terminus of said agreement line; thence South 89° 59' 08" West (Record West), 171.96 feet to the point of beginning.

Along a portion of the Westerly boundary monuments were set around a fence line encroachment and it was decided by the client to quitclaim interest to adjacent landowners instead of moving the fence line.
