SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250 ORRGON REVISED STATUTES

LOCATION:

Situated in the Northeast Quarter of Section 8,

Township 39 South, Range 1 East of the Willamette Base

and Meridian, Jackson County, Oregon.

PURPOSE:

To survey, monument and partition into two parcels of land, the present ownership of the clients as set forth hereinabove. Also, to dedicate to the City of Ashland all the right, title and interest that John and Tracy Darling, Karen Holley Darling, Margaret J. Brown and Howard Strom may have in and to the newly established right of way of Hitt Road and Strawberry Lane where contiguous to the dedicators ownership of record. Also, to establish easements and conditions as set forth in the Dedication and as shown on the accompanying map. Prepare legal descriptions for Parcels No. 1 and 2 as shown hereon.

PROCEDURE:

Utilizing the previously established alignment for Strawberry Lane as set forth on Recorded Surveys No. 7465 and 10851 proceeded to establish the Southerly right of way line as shown hereon. The exact location of Hitt Road has always been questioned. The closet possible retracement revealed that Hitt Road of record and the physical location were not one and the same. Therefore, a complete realignment of Hitt Road was undertaken with the results being as shown on the accompanying map. A condition of the dedication to the City of Ashland is that the governing body of said City vacate the old existing rights of way of record for Hitt Road and Strawberry Lane where the new dedication has now been established. Additional control was utilized as set and shown on Recorded Survey No. 10852.

To correct any possible title problems which may have occurred between the ownership of John and Tracy Darling and Margaret J. Brown, see Document Nos. 89-11210 and 89-11211 of the Official Records of Jackson County, Oregon.

BASIS OF BEARING:

True Meridian at the North-South centerline of Section 8 as derived from the National Oceanic and Atmospheric Administration (formerly Coast and Geodetic Survey) survey net established in 1968 and filed in the office of the Jackson County Surveyor.
