To monument and describe three parcels according to conditions of approval by the City of Shady Cove for a Minor Land Partition and the clients instructions.

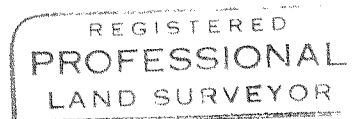
PROCEDURE:

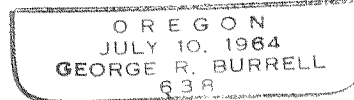
