William Henry Kneebone, Trustee for the HENRY KNEEBONE TRUST, UTD 2/2/87, state that the HENRY KNEEBONE TRUST is the owner in fee simple of the lands as described hereon and that I, William Henry Kneebone, Trustee, on behalf of the HENRY KNEEBONE TRUST, UTD 2/2/87, have caused the same to be surveyed and platted into lots, public utility and road slope easements, natural drainage way easement, riparian lands per City Land Use Ordinance, chapter 18.62 and a street as set forth hereon and that this plat is a correct representation of SUNNYVIEW HEIGHTS SUBDIVISION UNIT No. 2. I do hereby dedicate to the public, for street purposes, that street shown hereon as SUNSHINE CIRCLE. Said subdivision shall be subject to public utility and road slope easements as shown hereon. I do hereby dedicated to the City of Ashland, additional Natural Drainage Way Easement, where shown hereon, which is situated outside of that drainage easement as set forth in Document No. 77-03549 of the Official Records of Jackson County, Oregon. Cooke Cablevision or their successors in interest is hereby granted the right to use said public utility easements for underground placement of TV cable lines. marked with the proper monuments as provided by law the tract of land hereon shown and the plat is a correct representation of the same, and the following is

an accurate description of the boundary lines: ----

Commencing at a found 2 inch diameter Iron Pipe situated at the Accepted Quarter corner common to Sections 5 and 8, Township 39 South, Range 1 East of the Willamette Base and Meridian, Jackson County, Oregon: thence North 26°08'05" West a distance of 54.34 feet to a 6 inch diameter by 24 inch long concrete post with a 3 inch diameter bronze disk situated in the Westerly right of way line of Sunnyview Street and being the INITIAL POINT of Sunnyview Heights Subdivision Unit No. 2; thence along the arc of a 25.00 foot radius curve to the right, the long chord bears South 44°46'47.5" West, 35.53 feet, and the arc length is 39.52 feet to a found 5/8 inch iron rod situated in the Northerly right of way line of Orchard Street: thence North 89°55'55" West along said right of way line, 175.65 feet to a found 5/8 inch iron rod situated at the Southeast corner of Sunnyview Heights Subdivision, as now recorded; thence leaving said right of way line North 12°55'26" West along the Easterly boundary line of said Sunnyview Heights Subdivision, as now recorded, 72.74 feet to a found 5/8 inch iron rod: thence North 22°17'16" West, 133.04 feet to a found 5/8 inch iron rod; thence North 55°25'56" West, 107.53 feet to a found 5/8 inch iron rod: thence North 22°06'54" West, 58.13 feet to a found 5/8 inch iron rod: thence North 48°27'11" West, 79.09 feet to a found 5/8 inch iron rod; thence North 45°14'30" West, 46.62 feet to a found 5/8 inch iron rod; thence North 23°50'39" West, 52.27 feet to a found 5/8 inch iron rod; thence leaving the Easterly boundary line of said recorded subdivision, South 88°16'16" East, 272.10 feet to a found 5/8 inch iron rod; thence North 01°23'44" West, 99.81 feet to a found 5/8 inch iron rod; thence North 89°29'30' East, 217.19 feet to a found 5/8 inch iron rod situated in the Westerly right of way line of Sunnyview Street; thence South 00°30'30' East along said Westerly right of way line, 510.45 feet to the Initial Point.
