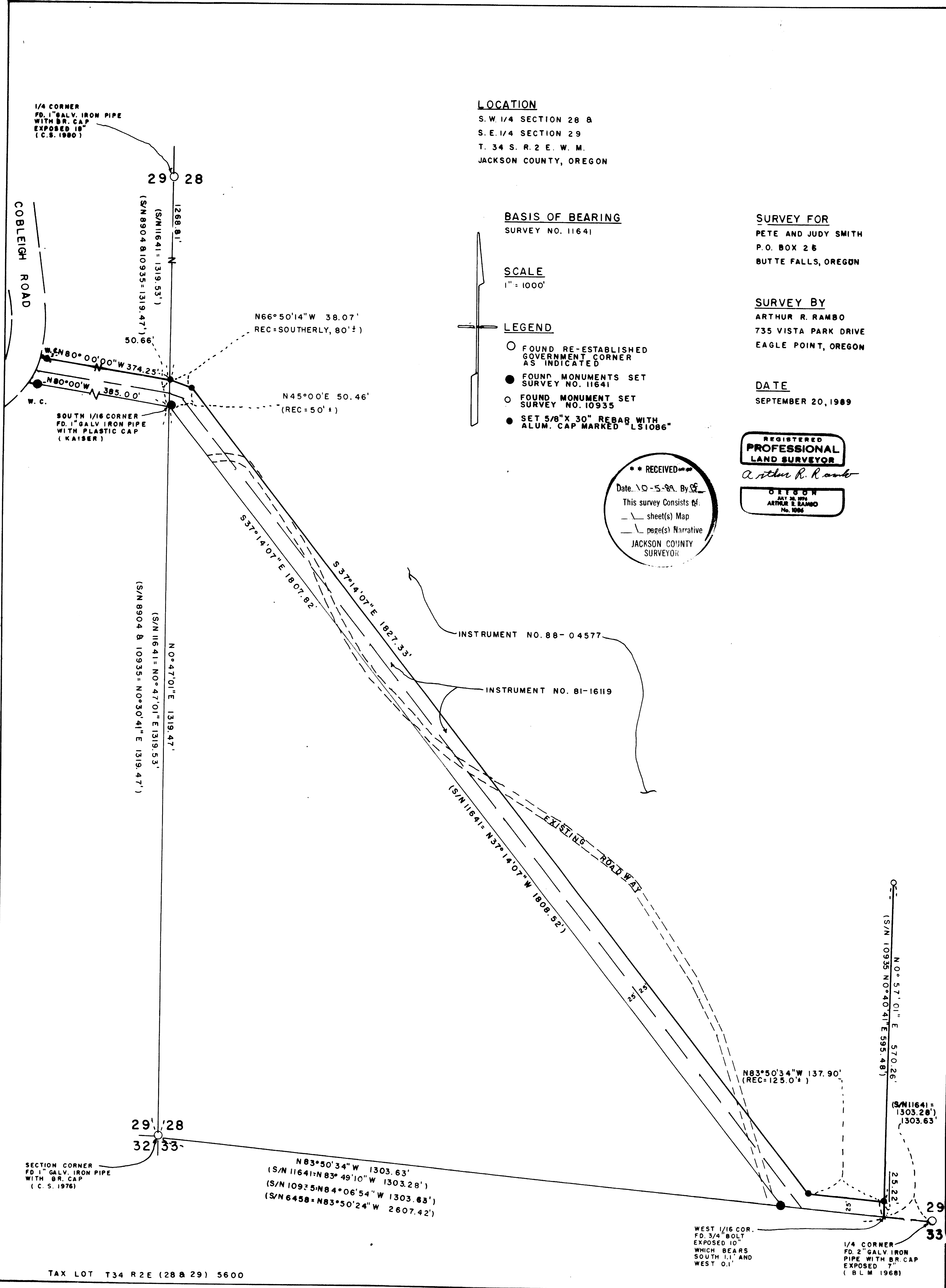

BASIS OF BEARING: Survey No. 11641

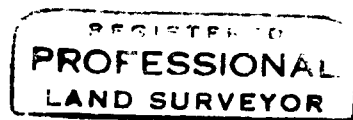
PURPOSE: To monument the Easterly and Southerly
boundries of tract described in
Instrument No. 88-04577 Jackson County.

PROCEDURE: Starting from the control network
established on Survey No. 10935, a traverse
was run tying to monuments set on Survey No.
11641. Distances established on Survey No.
10935 were held, and the bearings established
on Survey No. 11641 were held.

The position of the Southerly boundry
of tract described in Instrument No.
88-04577, which is also the Northerly
boundry of that 25 foot wide strip of
land described in Instrument No. 81-16119,
was computed. Monuments were set as shown
on the plat to accompany this narrative.

At the West one-sixteenth corner on
the South boundry of Section 28 found a 3/4"
Iron bolt of unknown origin which bears South
1.1' and 0.1' West. No monument was set for
the true corner position.
