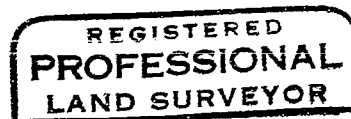
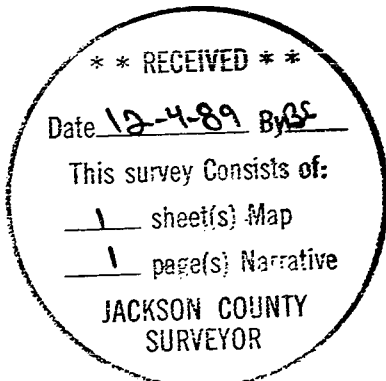
BASIS OF BEARINGS: FILED SURVEY NO. 3047

DATE: NOVEMBER 30, 1989

PURPOSE: To monument and describe adjusted
Tax Lot No. 36 1W 13-401. For
County approval see Jackson County
File No. 89-90-LLA.

PROCEDURE: Utilizing EDM equipment, tied the
county road center-line control, Northwest corner of Section
13 and traversed around the Subject tract. The Subject tract
boundaries were located per the clients instruction and in
accordance with the county approval.

The county road center line was located from the Alta
Vista Road notes and location map filed in the County
Surveyors Office. This location agrees with center line as
described in Volume 530, Page 521 Deed Records.
