

SURVEY NARRATIVE TO COMPLY WITH OREGON REVISED STATUTES 209.250

PURPOSE:

To survey and monument the two tracts designated as Tax Lots 601 and 902 on map 39-1W-3 with appropriate deed recording

numbers shown on attached map.

PROCEDURE:

A review of filed Survey No's 1450, 3661 and 10194 produced the survey control necessary to survey and monument the two subject properties. Both legal descriptions for the subject properties referred to monuments as set per S/N 3661 as did legal descriptions to the northwest and southwest of said property. With that, monuments were found as shown on attached map and new monuments were established according to client's request. Existing fence lines were not consistent with found monuments and their locations are noted relative to said monumentation. As of the writing of this narrative, a boundary line agreement is being prepared on monumented east boundary to clear up any ambiguity of title that may exist along the "reported west boundary of D.L.C. No. 37".

Fd. 5/8" iron pin w/yellow cap S 28° 25' 50" W 38.72 feet (Rec.

Fd. 5/8" iron pin badly bent and reset at S 40° 13'14" E 31.94' Fd. 5/8" iron pin 3" below asphalt N37° 14' 19" E 3.02 feet
