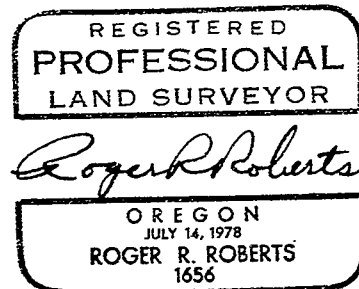
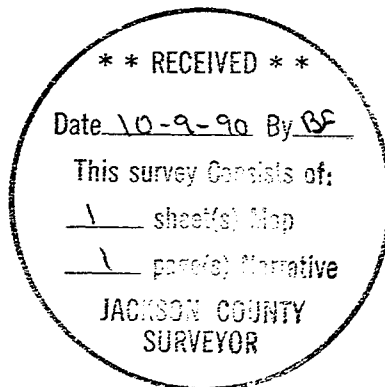
LOCATION: Lot 6 of ROGUEWOODS ESTATES SUBDIVISION, in the NE
