MINOR LAND PARTITION IN LOT "S" OF SNOWY BUTTE ORCHARDS in Section 10, Township 37 South, Range 2 West of the Willamette Meridian, Jackson County, Oregon.

PURPOSE OF SURVEY:

To create a minor partition in Lot 1000, Map No. 37 2W 10DA.

Bearings are based on monuments found on the North line of Beall Lane. Surveys of reference being No.'s 30, 60, 878 and 1683. I also ran to a $3\frac{1}{2}$ inch iron pipe marking the Northwest corner of Lot "A" of SNOWY BUTTE ORCHARDS. This corner had been identified with a brass cap which has been removed. The pipe was found to be firmly planted and did not appear to have been disturbed. The location, with respect to other monuments found and identified, was quite acceptable.
