## NARRATIVE

SURVEY FOR: Mr. Ivan Sparks
c/o Fair City Real Estate Central Point, Oregon 97502

LOCATION:

NE 1/4 of Section 19, Township 36 South, Range 2 West, of the Willamette Meridian, Jackson County,

Oregon.

PURPOSE:

To run and mark the West and South line of Tax Lot 500 and to monument a proposed Boundary Line Agreement as shown on accompanying plat.

DATE:

January 31, 1992

BASIS OF BEARING:

Bearings based upon Recorded Survey number 10695.

PROCEDURE

Tied the North and East 1/4 corners and the CE 1/16 corner. Computed the C 1/4 of Section 19, by a bearing-bearing intersection from the N 1/4 and the E 1/4. Distances checked very close with Recorded Survey number 10695, so this position was held. At said C 1/4 set:

A 5/8"x 30" rebar with yellow plastic cap marked, "TEMPLIN LS 2359", from which scribed following bearing tree:

A Black Oak, 6" diameter bears N 20°E, 5.9 feet, scribed " C1/4S19" "BT".

A White Oak, 4" diameter bears N 67°E, 23.9 feet,

scribed " C1/4S19" "BT". A Black Oak, 8" diameter bears S 63030'E, 46.8 feet, scribed "Cl/4S19" "BT".

A Black Oak, 6" diameter bears S 21°W, 31.6 feet, scribed " C1/4S19" "BT".

I then ran N 00°07'17" W, along the North-South centerline of said Section, 1458.41 feet and set a monument, closing then to the N 1/4 corner. Said line was then blazed and painted. I then returned to the C 1/4 and ran S 89°40'42" E, along the East-West centerline of said Section, 727.48 feet and set the SE corner of O.R. 76-20569.
