


SURVEYOR'S CERTIFICATE

I, Richard G. Templin, a duly registered surveyor of the State of Oregon do hereby certify that this plat correctly represents a survey made by me and complies with regulations for Minor Land Partitions and the following is an accurate description of the parent tract of land, as set forth hereon:

Commencing at a point on the North line of Donation Land Claim Number 63, in Section 23, Township 38 South, Range 1 West of the Willamette Meridian, Jackson County, Oregon, from which the Northeast corner of said Claim bears South 89°58'57" East, 660.00 feet; thence South 00°19'10" East parallel with the East line of said Donation Land Claim No. 63, 211.58 feet to a 5/8" iron rod monumenting the INITIAL POINT OF BEGINNING; thence continue South 00°19'10" East, 211.56 feet (Record 211.57 feet) to a 5/8" iron rod; thence South 89°57'52" East, 188.11 feet (Record South 89°58'57" East, 188.05 feet ) to a brass cap monument on the West line of CHRISTAIN ACRES; thence North 00°12'25" West along said West line, 169.35 feet ( Record North 00°12'28" West, 169.33 feet) to a 5/8" iron rod on the South right of way line of First Street; thence North 89°55'10" West along said South line, 49.23 feet to a 5/8" iron rod; thence along a 50.00 foot radius curve to the right, 70.77 feet ( the long chord of which bears North 49°27'40" West, 65.01 feet ) to a 5/8 iron rod; thence North 89°58'59" West, 90.05 feet (Record North 89°58'57" West, 90.01 feet ) to the true point of beginning.
