PURPOSE:

To survey and monument two parcels created through

a Minor Land Partition.

PROCEDURE:

The Northerly and Easterly boundaries of this Partition were monumented and or computed by this office during Survey No. 12780. From control established during Survey No. 12780, ties were made to the N.W. corner of D.L.C. No. 69, to the pin set by Survey No. 1599 and to Station #26 for a Geodetic tie. The West Boundary was accepted as monumented by Survey No. 8193 and Boundary Agreement Document No. 92-01662, Official Records of Jackson County, Oregon. The South boundary along Valley View Road was calculated from data from Survey No. 1599 and centerline data described in Volume 186, Page 378, Jackson County Deed Records. As per the tentative plat the position of the Parcel corners were computed and set as shown on the attached Plat. The found pin at the Initial Point set by Survey No. 1599 was replaced with a 5/8" x 30" iron pin with plastic cap mkd. L.J. FRIAR & ASSOCIATES.

Beginning at the Southwest corner of D.L.C.
