PURPOSE:

To survey and monument the corners of four parcels created through a Minor Land Partition and Lot Line Adjustment.

PROCEDURE:

Tied various monuments set 7543, 11704, 12281 and other surveys in the immediate area into a closed loop traverse. Ties were also made to the N.E. corner of D.L.C. No. 40, street centerline monuments and to Geodetic control monuments as shown on Sheet 2. The North boundary of the subject tract was monumented by Survey No. 12281. The West boundary was monumented by Survey Nos. 7543 & 11704. The centerline of Nevada Street was held at map record bearing from the centerline monument at Oak Street per Survey No. 11704, et al.
