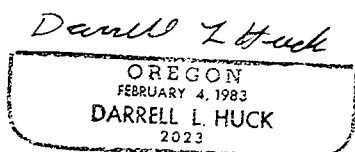
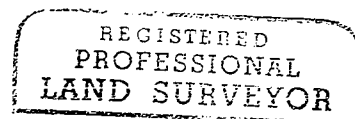
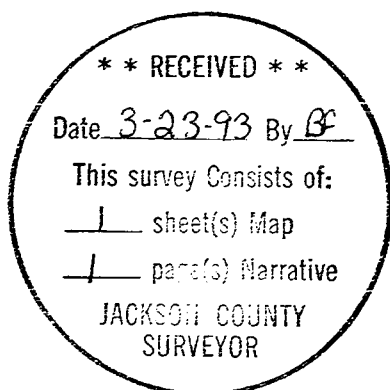
Location: Donation Land Claim No. 43 in the Northwest  
one-quarter (1/4) of Section 10, Township 39  
South, Range 1 East, Willamette Meridian,  
Jackson County, Oregon

Purpose: To survey and monument that tract of land as  
described in Document No. 81-14943, Official  
Records of Jackson County, Oregon

Procedure: Utilizing a one-second theodolite and  
electronic distance measuring equipment, a  
control traverse was run tying found monuments  
as shown on the attached map. The North line  
of the subject tract has been surveyed as  
shown on Recorded Survey No. 12244. The  
location of the South line was computed and  
monuments were set according to the client's  
request.
