

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 205.250 OREGON REVISED STATUTES

SURVEY FOR:

Andrea Mobley P.O. Box 4621 Medford, Oregon

LOCATION:

South half of Section 13 in Township 39 South, Range 3 West of the Willamette Meridian, Jackson County, Oregon.

PURPOSE:

Verify the location of the north-south centerline of Section 13, and to locate and map the improvements that are immediately to the west of the line.

PROCEDURE:

An electronic distance meter traverse was between the monument at the south 1/4 corner to the monument at the center 1/4 corner of Section 13, with ties to the two found monuments at the north end of the property. The resulting measurements compared reasonably with those shown on the map of File Survey No. 7085.

Measurements were taken to the house additional improvements found to be west of and section centerline, as shown on the accompanying map.


