PURPOSE:

To survey the center line of an existing driveway from the North right of way line of Interstate
Highway No. 5 to Tax Lot 200 located in the
West 1/2 of the West 1/2 of Section 19, Township 36 South, Range 4 West, Willamette Meridian, Jackson County, Oregon.

PROCEDURE:

Beginning at the South 1/16 corner at which point I found a 5/8" iron rod per C.S. 6016 from which I found

> A W.Oak 11" in diam. North 77° East 28.57feet, blaze healed. A B.Oak 13" in diam. North 46° West 29.76 feet, blaze healed.

Thence I traversed to the West 1/4 corner at which point I found a 1/2" iron pipe with a metal cap per C.S. Book 8, Page 137 from which I found

A 5/8" iron rod South 26° West 8.6 feet. A W.Oak 7" in diam. North $40-1/2^{\circ}$ East 35.7feet, blaze healed. A Madrone 10" in diam. North 27° West 22.2 feet, blaze healed.

Thence I surveyed to State Highway right of way monuments as shown; thence I surveyed the center line of the existing driveway as shown on the map.

Basis of bearing C.S. 3399.
