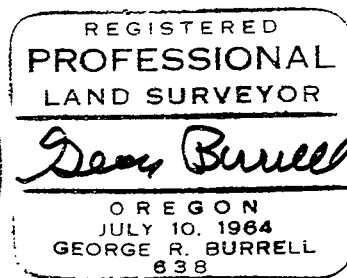
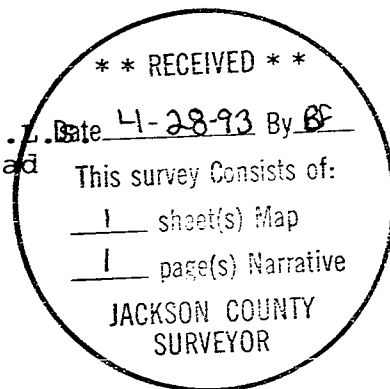
PROCEDURE:
