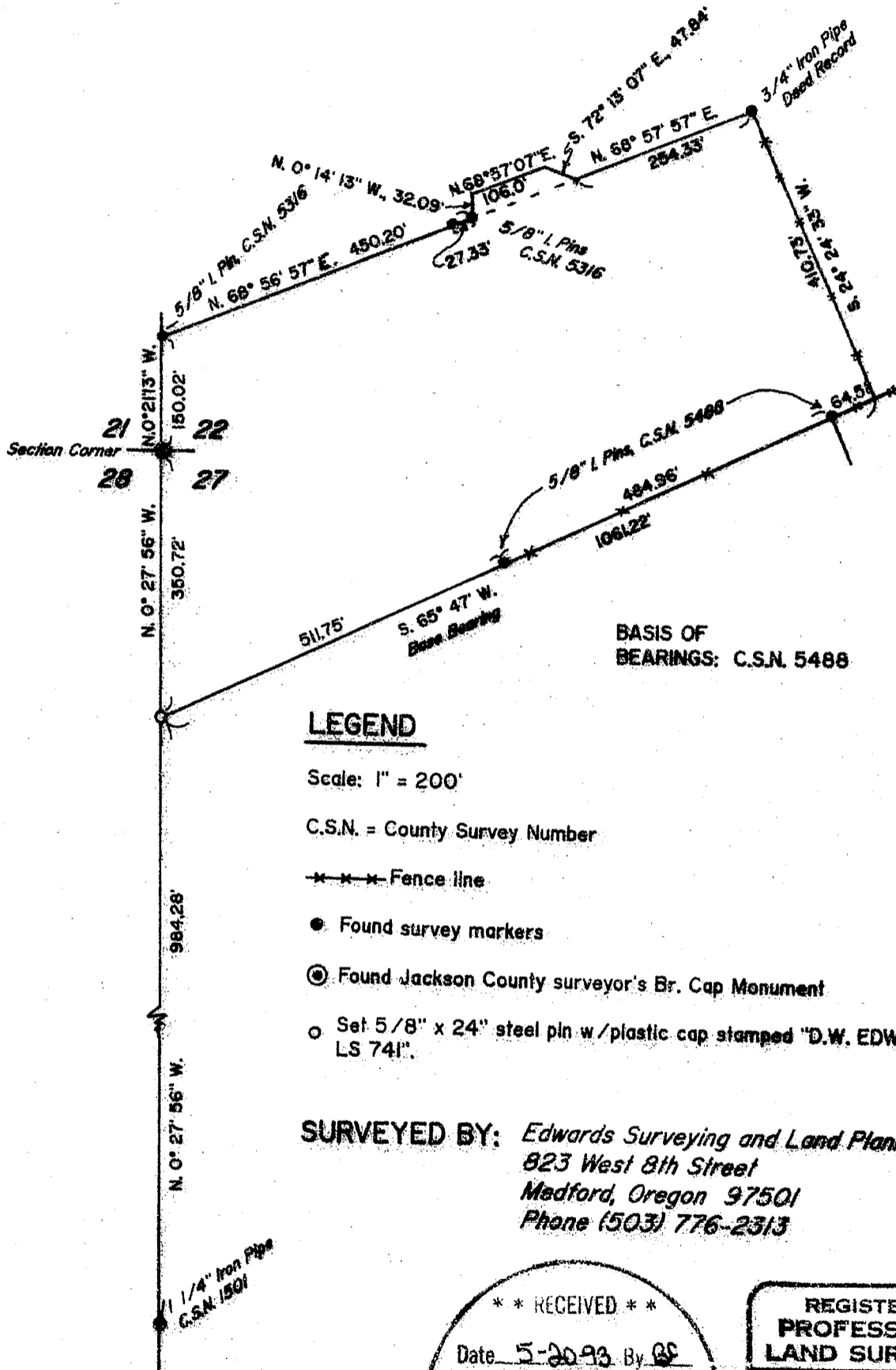


MAP OF SURVEY

Meridian in Jackson County, Oregon.

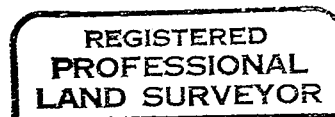
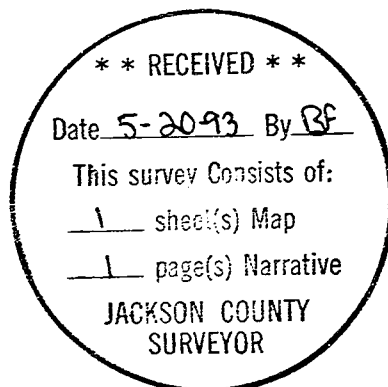
PURPOSE: To survey and monument Tax Lot 3600, according to

as shown on the accompanying Map of Survey.

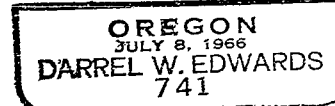
