

SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE:

To survey and monument the dividing line of two parcels created through a Minor Land Partition. See JCDPD File No. 89-34-MJP.

PROCEDURE:

From control established by this office during Survey No. 11027, calculated the position of and set pins at the corners of the dividing line between the Parcels. The Southeast corner of Parcel 1 fell in the water of West Fork Trail Creek, so a Witness Corner was set. The pin on the Southerly line of Parcel 1 was set in the fence running along side of West Fork Trail Creek Road. Those monuments found as well those set are as shown hereon.
