Hunts and Jane Stradley Hunts, husband and wife are the owners in fee simple of the lands hereon described, and that we have caused the same to be subdivided into lots and streets as shown hereon, and the number and size of the lots and the lengths of all lines are plainly set forth, and that this plat is a correct representation of the subdivision, and we do hereby dedicate to the public for public use the streets shown, together with all public utility easements as shown hereon and we also dedicate to the public that 14-foot wide drainage easement across Lots 19, 20, 21, 22 and 23.
