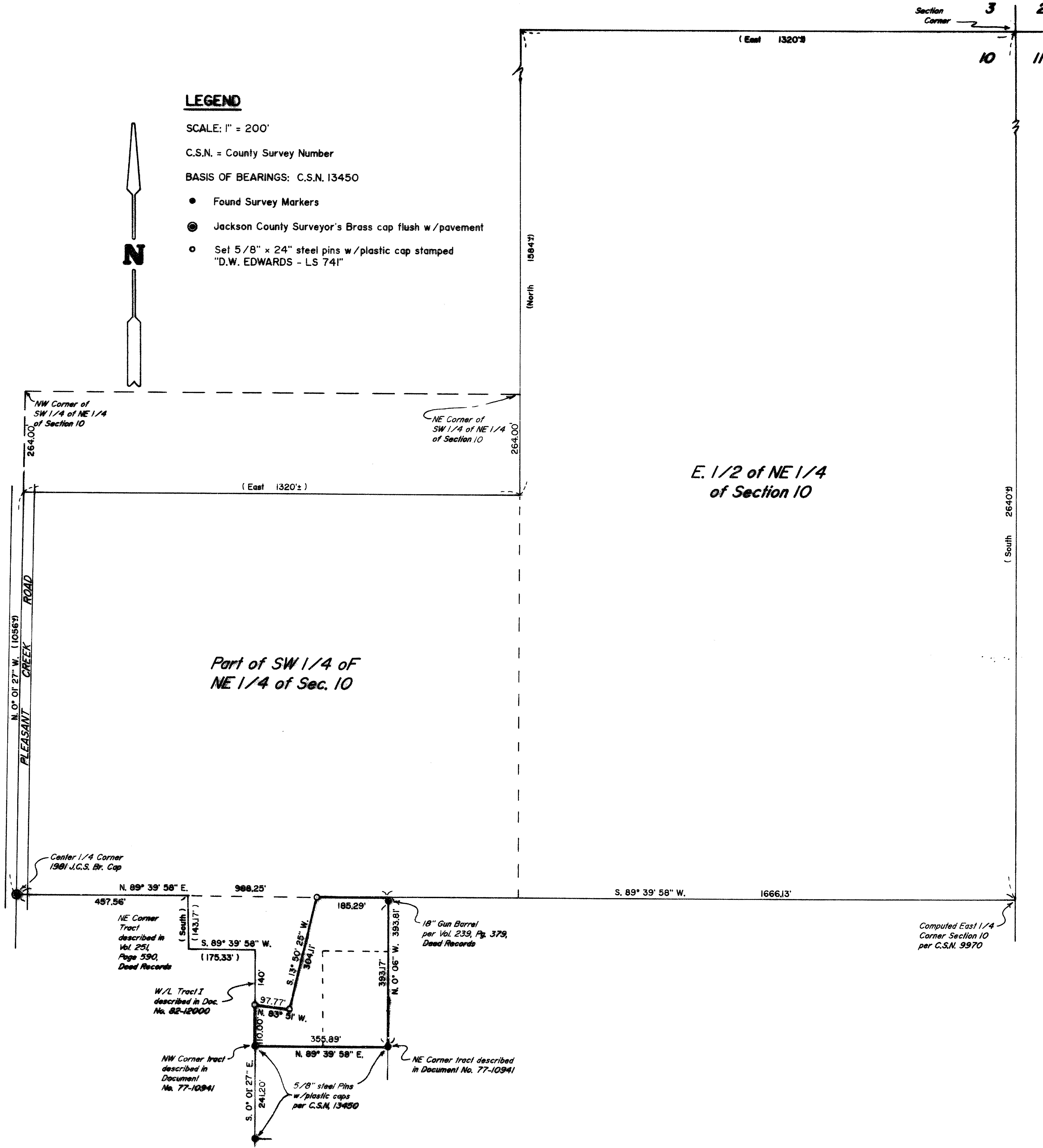

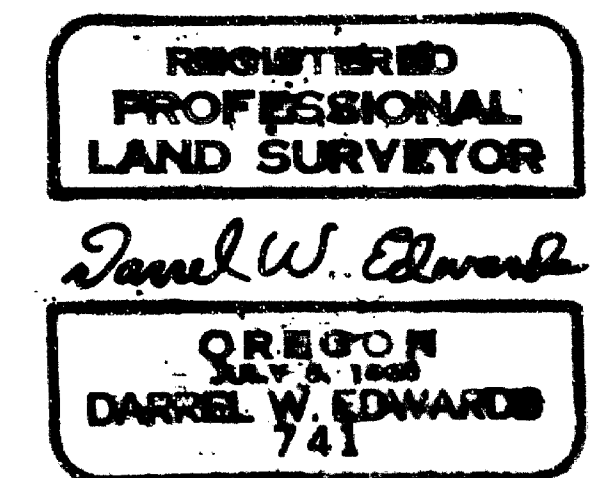
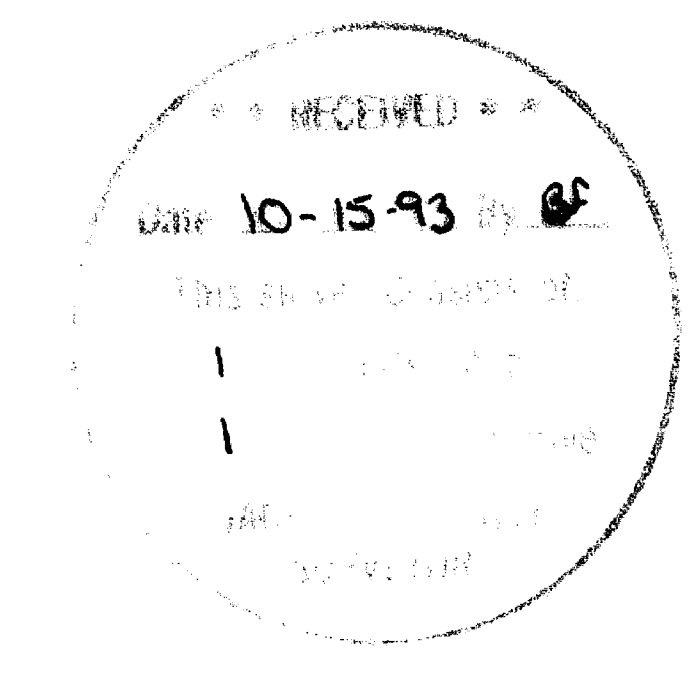

Oregon.

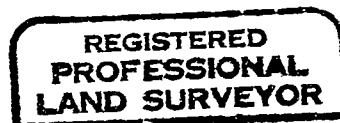
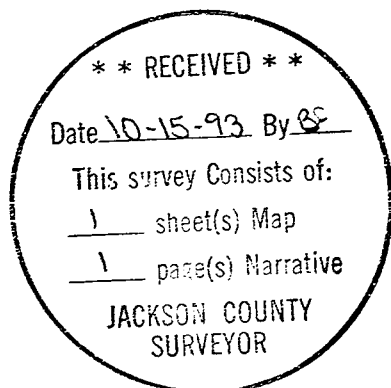
PURPOSE: Property Line Adjustment survey as shown on the

caps stamped "D.W. EDWARDS-LS 741".

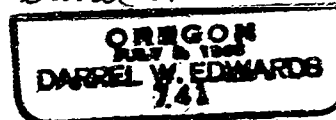
