



Conclusion

The 20" fir is plainly mkd., and slight discrepancy in the angular measurement I attribute to soil creep, as this cor. falls on a 38° north slope. The cor. is set at record dist. from the BT's without regard to angular calls.

THE SUBDIVISION OF SECTION 32, TOWNSHIP 35 SOUTH,
RANGE 3 WEST, W.M., JACKSON COUNTY, OREGON, 1959

This survey is executed with a Leupold light mountain transit with double opposite verniers reading to one minute of arc. The distances are measured with a Lufkin etched $\frac{1}{4}$ in. steel tape 200 ft in length. The distances are measured on the slope, the vertical angle determined and the distances reduced to the horizontal.

At a point on the N. boundary of the section on Nov. 29, 1959 I observe the star Polaris to determine meridian. All bearings used in this survey are carried forward by angulation from this observation.

At the corner of Secs. 29, 30, 31 and 32, monumented by a Model T axel, referenced as described in the off. record.

N. $89^{\circ} 57' E.$; Desc.along steep N. slope through heavy under brush.
