LOCATION:

The Southeast 1/4 of Section 28 and the Northeast 1/4 of Section 33, Township 37 South, Range 1 West, Willamette Meridian, City of Medford,

Jackson County, Oregon.

PURPOSE:

To set the deferred monumentation for ALDER CREEK - PHASE NO. 3 -A PLANNED COMMUNITY as shown on the plat recorded in Volume 15,

Page 28, Plat Records, Jackson County, Oregon.

EQUIPMENT:

Leitz Set 4 Total Station

PROCEDURE:

The boundary of Alder Creek - Phase No. 3 has been changed by City of Medford Ordinance No. 7476, which vacated a portion of the subdivision. All of the deferred monuments within the remaining portion were set at the locations shown on the original plat with the exception of three witness corners which were set at the locations shown on this survey due to conflicts with constructed facilities. In addition, several of the lot corners which were originally set west of Alder Creek Drive were either removed or buried during construction which took place approximately eight years ago. These corners were reset at record bearing and distance from the

centerline of Barnett Road.

BASIS OF BEARING:

The centerline of Barnett Road between the monument found at the intersection of Golf View Drive and the P-K nail found near the intersection

with North Phoenix Road as shown on RS 9991, and RS 13349.




