

## MAP OF SURVEY

SURVEY NARRATIVE TO COMPLY WITH CHAPTER 209, PARAGRAPH 250, OREGON REVISED STATUTES

LOCATION:

In the SW 1/4 of Section 29, & in the NW 1/4 of

Section 32, T. 37 S., R. 1 W., W.M., in the City of Medford, Jackson County, Oregon.

PURPOSE:

To locate and monument the boundaries of tax lot 5001, being described in Doc. No. 90-04115, Official Records for Jackson County, Oregon.

PROCEDURE:

A control traverse was executed which tied in the controlling monuments as shown on the accompanying map. The description found in the noted Doc. No. was obviously written from data shown on Survey Number 2260. The procedure used on that survey to establish the West boundary is in my opinion erroneous. It would appear that the intent of descriptions in Vol. 248, Pg. 604 and in Vol. 266, Pg. 365 was to match their West lines with the East line of Vol. 177, Pg. 255 and the southerly projection thereof. This line is described as being 1234.5 feet East from the West line of D.L.C. No. 50. This is the procedure used on S.N. 4592 and S.N. 6726 and fits the improvements on the ground. The monuments and boundary locations established on S.N. 8493 were held to as shown. Monuments set on this survey consist of 5/8" x 30" steel pins with red plastic caps mkd. "D.A. EDWARDS-LS 2339" or a lead and tack set in conc. w/brass tag mkd. "L.S. 2339".
