
A D.Fir 26" in diam. South 28-1/2° East 29.0 feet, blaze healed.

Thence I traversed back to the West 1/4 corner of said Section 30; thence I computed the position of the 1/16 corners as shown on the map; thence I surveyed and set said corners and marked true line between them as indicated.

Basis of bearing C.S. 9428.

The survey was conducted with a Nikon DTM-A10LG Total Station.

A Fir stump 13" in diam. South 64-1/2° West 8.65 feet, scribe visible.

Thence I traversed to a point designated as the Center 1/4 corner per Surveys 9428 and 11770 from which I found a 5/8" iron rod per C.S. 6065 South 79°11' East 2.67 feet; thence I traversed to the West 1/4 corner at which point I found a 1986 C.S. brass cap from which I found

A Cedar 13" in diam. South 38-1/2° East 61.15 feet, blaze healed.
A Madrone 16" in diam. North 37-1/2° West 20.57 feet, scribe visible.
A D.Fir 11" in diam. North 19° East 19.14 feet, scribe visible.

Thence I traversed to the West 1/16 corner at which point I found a 1" iron pipe per C.S. 2116 from which I found

A D.Fir stump 10" in diam. South 73° West 13.2 feet, blaze healed.
A B.Oak 18" in diam. down and dead North 25° West 26.4 feet, blaze healed.

Thence I traversed to the Northwest section corner at which point I found a 2" iron pipe per C.S. 2116 from which I found

A W.Oak 14" in diam. North 29-3/4° East 103.6 feet, blaze healed.
