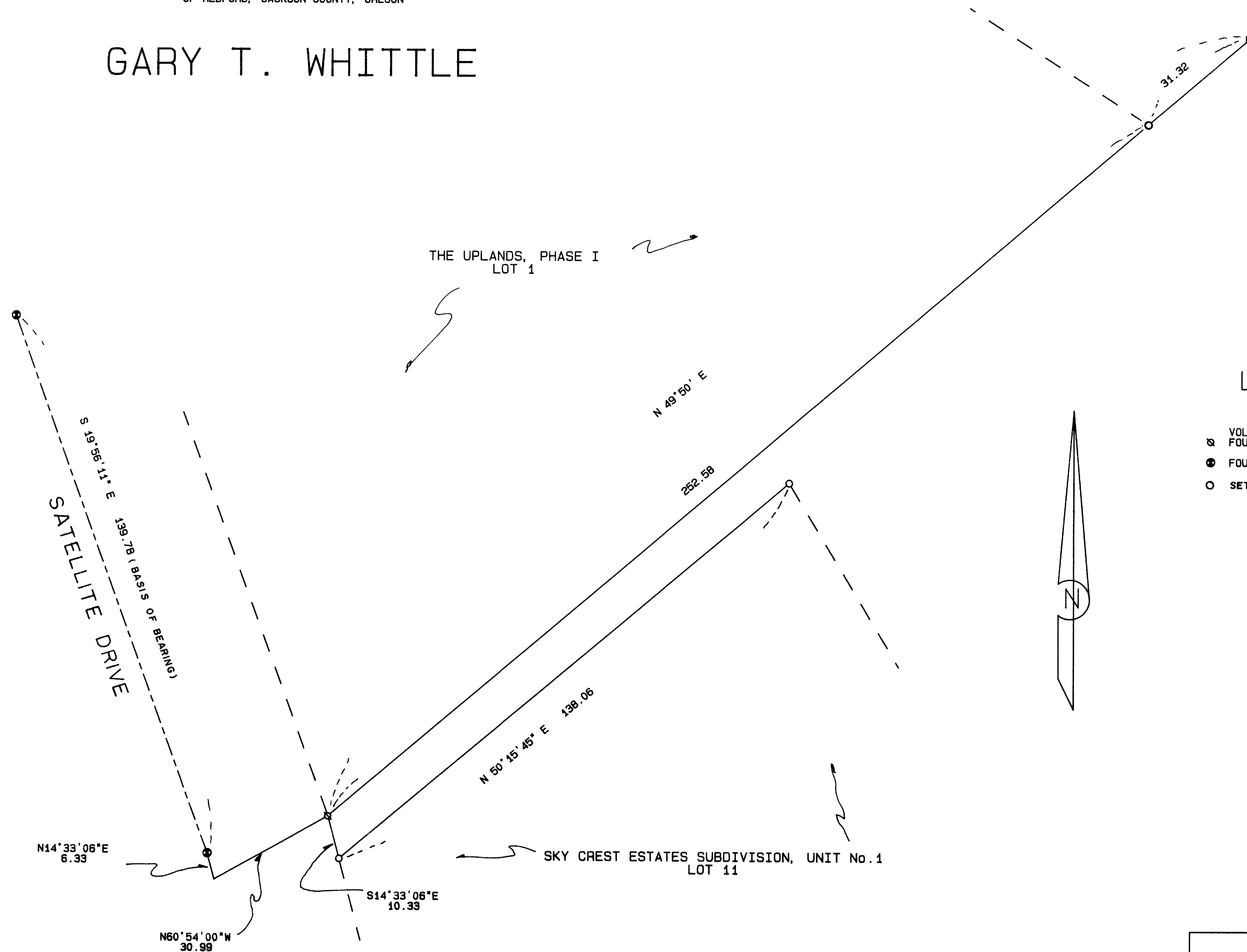


MAP OF SURVEY

during construction.

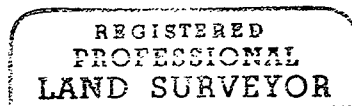
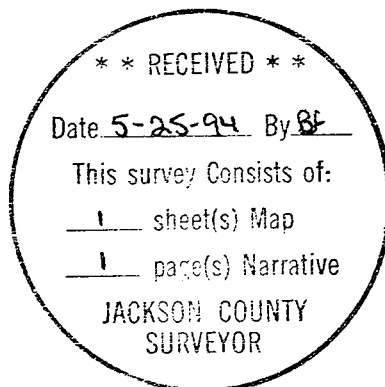
Procedure: Utilizing control established by this office

as shown on the accompanying plat.

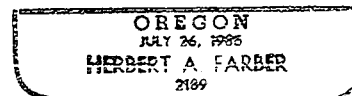
