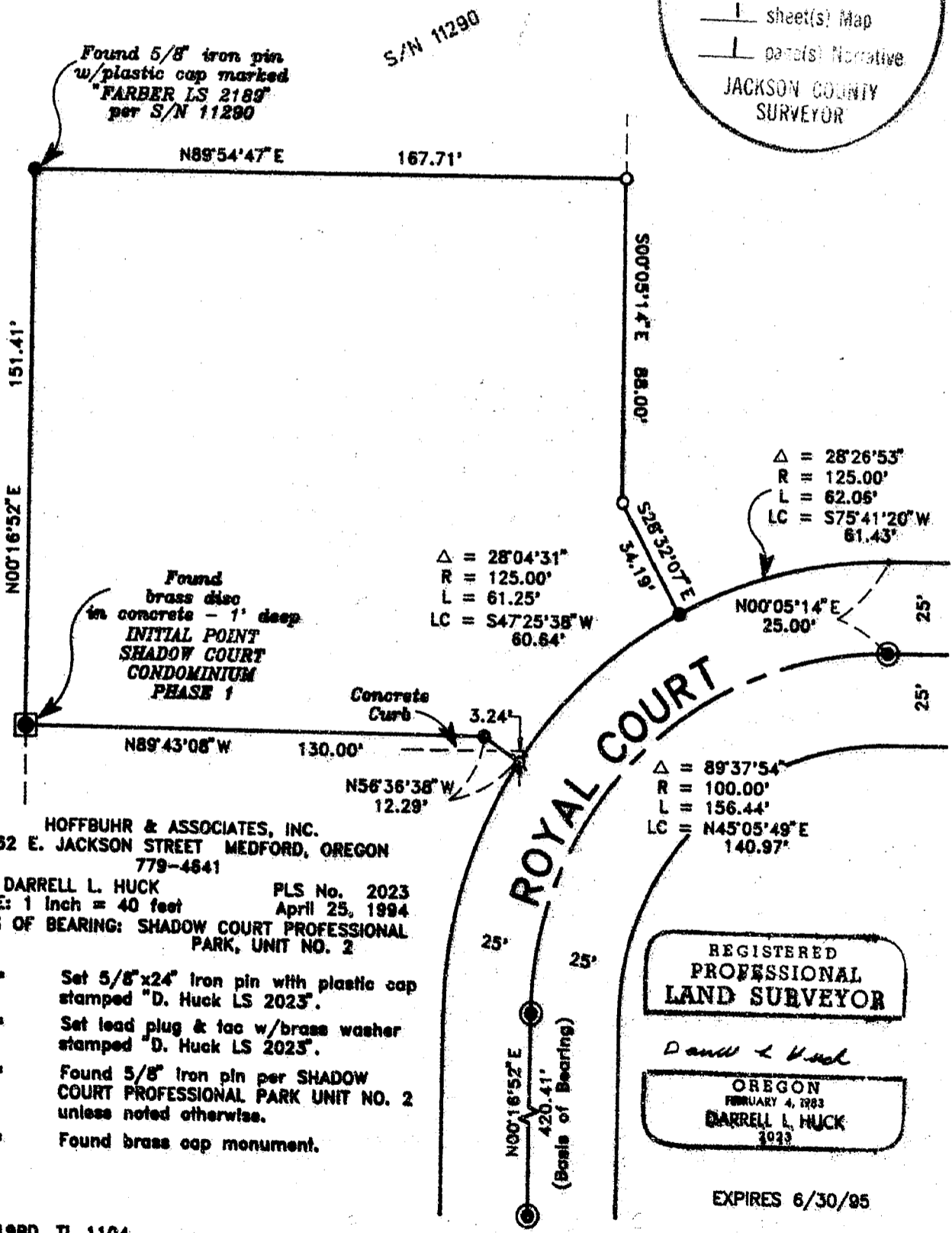
MAP OF SURVEY For ROGUE FEDERAL CREDIT UNION

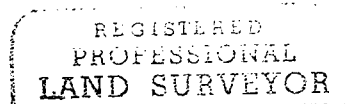
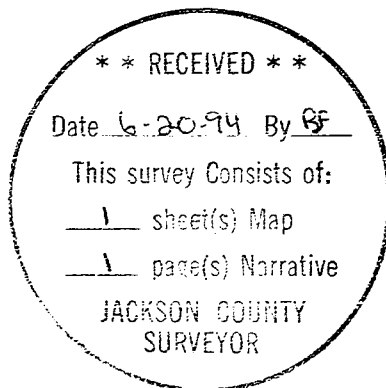
Location: Northwest one-quarter (1/4) of Section 19, Township

described in Instrument No. 93-06075

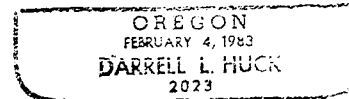
Procedure: The boundary had been previously monumented per
