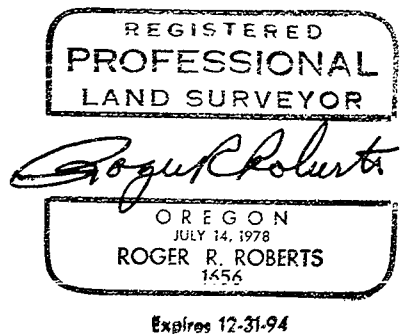
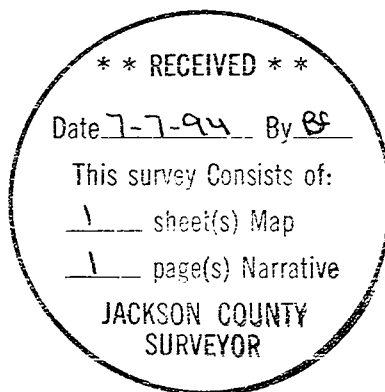
LOCATION: GRAND VIEW ORCHARD TRACTS, in the southeast quarter

Oregon.

PURPOSE: To reset two monuments that were incorrectly placed
during the course of Filed Survey No. 13038 in
1992.

PROCEDURE: During the course of what is now Filed Survey No.
13038, a 6.0 ft. jog in the east boundary of Lot 9
of GRAND VIEW ORCHARD TRACTS was inadvertently
overlooked when computing the positioning of the
common boundary between Lots 11 and 12. New
monuments were set 2.99 feet easterly of the
monuments previously set, and the older monuments
were removed.

boundary of Donation Land Claim
No. 55.

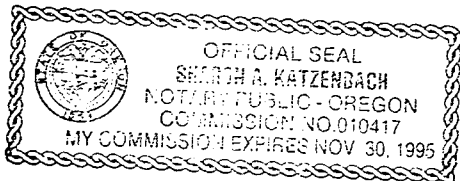
