(All distances are measured to a spike placed side center at the root crown of the Bearing trees, unless otherwise noted. Likewise, bearings are taken to the top of the Bearing Tree blaze and all Bearing Tree diameters are taken at breast height, unless noted otherwise.)

1/4 CORNER COMMON TO SECTIONS 24 & 23; TOWNSHIP 40 SOUTH, RANGE 2 EAST

Found: A standard B.L.M. 3 inch brass cap on a 2 & 1/2 inch galvanized iron pipe, exposed 3 inches, firmly set and marked: "U.S. Dept. of Interior, T40S R2E, 1/4 S23 & S24, 1968 Cadastral Survey B.L.M." from which:

A 13.5 inch O.B.T. oak shell bears S41 07'E, 30.5 feet dist. with axe work & no scribing evident.

(as per 1968 B.L.M. Re-estb.: 9" W.oak, S42 E, 47 links dist.) A 30 inch O.B.T. madrone bears S52&1/2 W, 45 links dist. with a opened blaze & no scribing evident.

BEARINGS: The 1968 Bureau of Land Management Dependent

Resurvey at the East-West Centerline of Section

24.

PROCEDURE: A thorough research of the public records revealed that there had been prior survey work done in Section 24. The original survey of this Township was done by Nathaniel Ford in 1855 under Government Land Office Contract No.55. The Southeast tier of Sections in this Township are exceptionally wide in an East-West direction. It is surmised that Surveyor Ford made a correction along the west boundary of Section 24 to bring the subsequent Sections he surveyed Northerly of this Section in closer conformance to the acceptable dimensions for the Section Boundaries for that time period. Peter Applegate re-established the East 1/4 corner of Section 24 in 1893. The Bureau of Land Management's Dependent Resurvey of the East Boundary of Township 40 South, Range 2 East then re-established his location for the East 1/4 corner as well as re-establishing the South, and West 1/4 corners based on filed survey No. 1495 and 1497 performed by Surveyor Lovejoy. The B.L.M. set the North 1/4 corner and the East 1/16th corner common to Sections 13 and 24 by proportionate measurement. The found B.L.M. monumentation at these locations were found to be within very acceptable positional tolerances on the East One/Half of the North Boundary of Section 24 (as per the B.L.M. 1973 Manual of Instructions). However, the West One/Half was found to be marginally acceptable only when related overall. Accordingly, these found locations were held in the subdivision of this Section.

Document No. 68-06223 of the Official Records of Jackson County, Oregon excepts the West 23 acres of the Southwest One/Quarter of the Northwest One/Quarter of Section 24. A cut-off bearing was determined for the East line of the Westerly 23 acres by proportioning the overall bearing difference between the Westerly and Easterly lines relative to the retraced acreage of the said Southwest One/Quarter. A fence of convenience was found meandering Southeasterly from the North 1/16th corner common to Sections 23 and 24 to the cattle guard on B.L.M.'s Emigrant Creek Road shown on the Stark Property. The fence then follows the southeasterly right of way line of Emigrant Creek Road to a point approximately 180 feet westerly of the Southeast property corner of the Westerly 23 acres. My clients were both appraised of this situation in regards to the surveyed lines to their apparent satisfaction.
