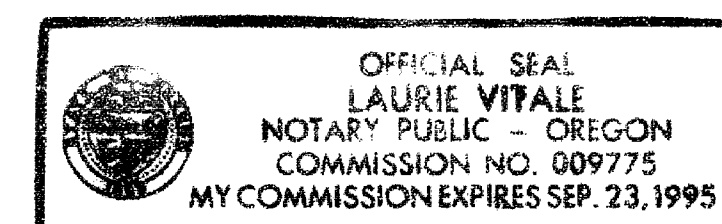

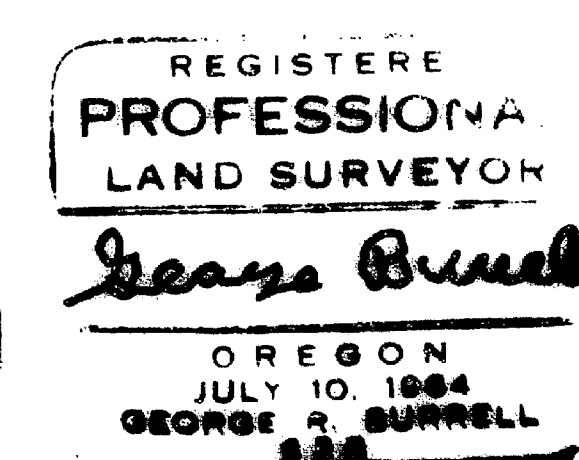
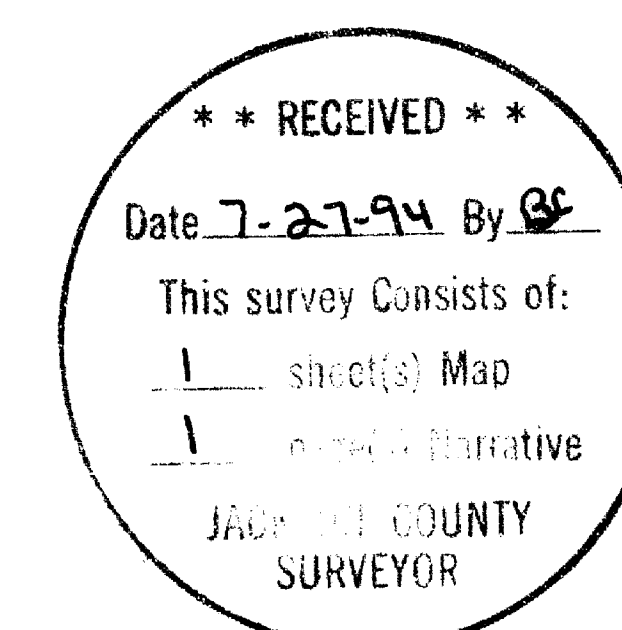


SURVEYOR'S CERTIFICATE

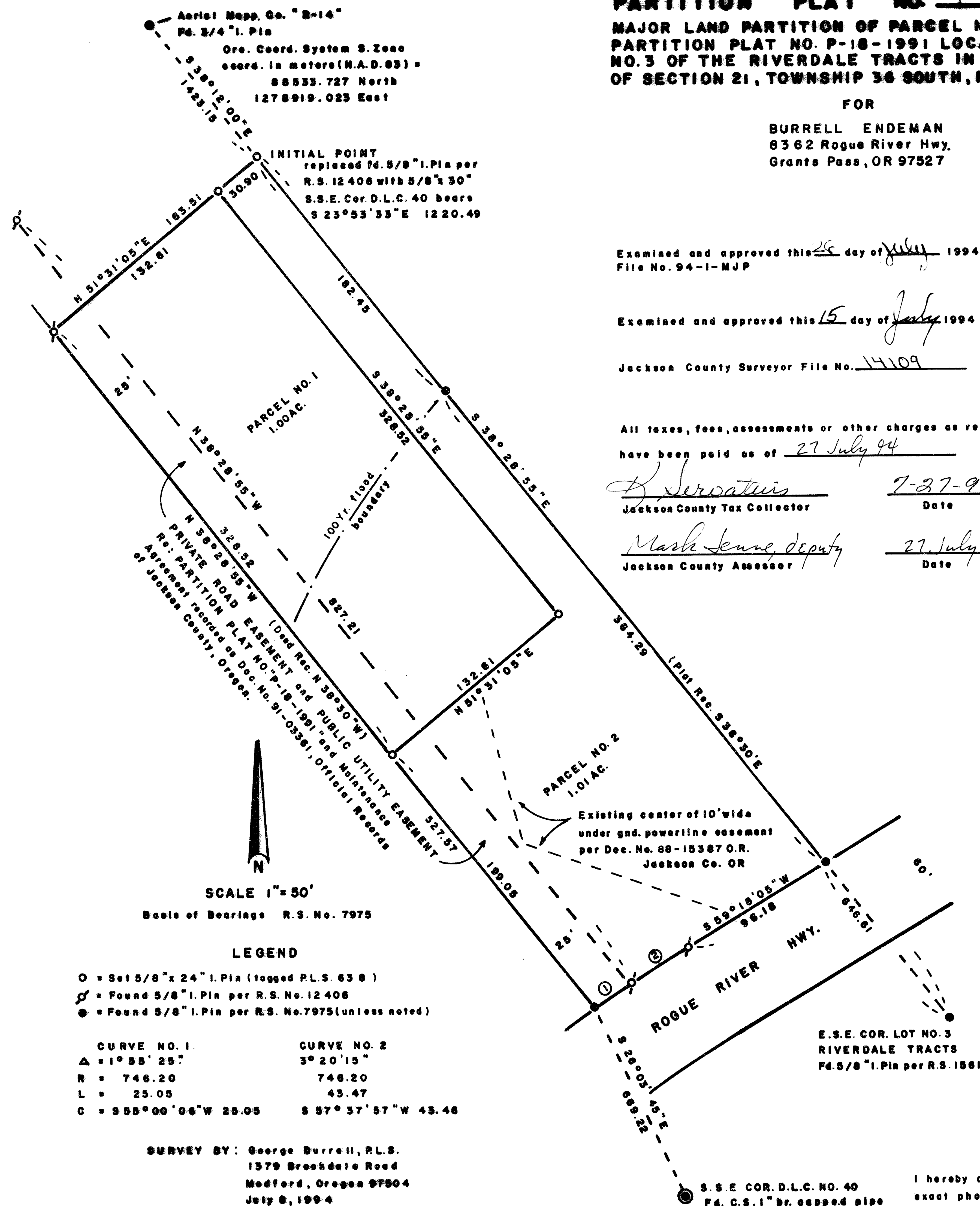

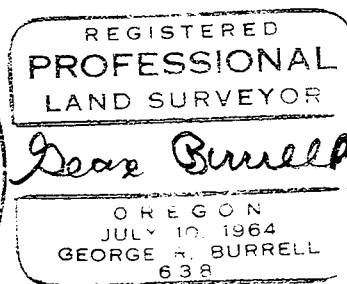
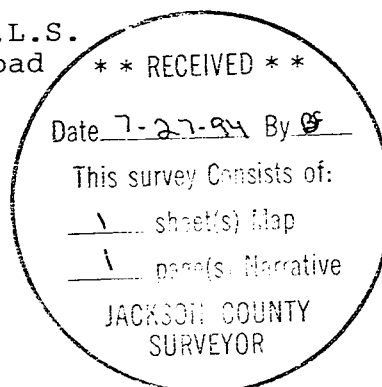
