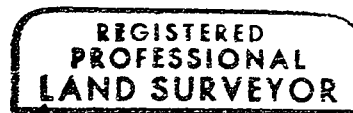
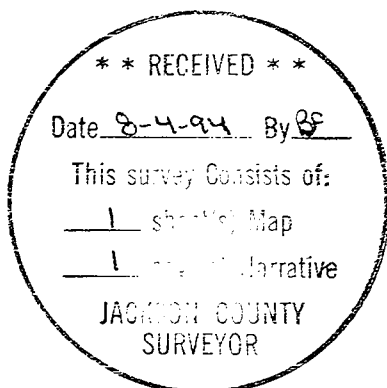
PURPOSE: PROPERTY LINE ADJUSTMENT; County Planning
