I, Douglas C. McMahan, a duly Registered Professional Land Surveyor of the State of Oregon, do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the plat is a correct representation of the same, and the following is an accurate description of the boundary lines.

BEGINNING at a brass disc in concrete marking the most Easterly Southeast corner of CHERRY LANE ESTATES SUBDIVISION, UNIT NO. 2, according to the Official Plat thereof, now of record in Jackson County, Oregon, said brass disc being the INITIAL POINT OF BEGINNING; thence along the boundary of said Subdivision, North 00°20'30" East 144.77 feet; thence North 89°39'30" West 167.92 feet; thence North 50°14'48" West 50.00 feet; thence along the arc of a 100.00 foot radius curve to the right (the long chord to which bears South 65°02'51" West 85.45 feet) an arc distance of 88.29 feet; thence North 00'20'30" East 160.00 feet; thence North 89'39'30" West 80.00 feet; thence leaving said Subdivision boundary, North 00°15'30" East 617.68 feet to a point on the Northerly line of Section 27, Township 37 South, Range 1 West of the Willamette Meridian in Jackson County, Oregon; thence along said Northerly line, South 89'48'25" East 294.26 feet to a brass disc marking the one-guarter (1/4) corner common to Sections 22 and 27, said Township and Range; thence continue along the Northerly line of said Section 27, South 89'50'18" East 444.26 feet; thence South 00'00'08" West 919.85 feet to the Northeast corner of CHERRY LANE ESTATES SUBDIVISION, UNIT NO. 1, according to the Official Plat thereof, now of record in said Jackson County; thence N89°39'30"W along the Northerly boundary of said subdivision, 379.26 feet to the Initial Point of Beginning.
